

- c) The President, Institute Director and Placement officer/ Alumni Coordinator together shall decide the conduct of Executive Committee meetings.
- f) The quorum for the Executive Committee Meetings shall be six in addition to *ex-officio* members.
- g) The notice for the Executive Committee Meetings shall be given at least 21 days before the meeting.
- h) The Executive Committee shall be vested with the following powers:
- To do all activities for carrying out the objectives of the Association.
 - To represent the Association in all matters and generally to do all acts and take all steps as may be necessary for the proper management of the Association.
 - The Secretary shall represent the Association in all Legal Transactions by or against the Association.
 - To take emergency decisions beneficial to the Association and ratify it in next General Body Meeting.

V. FUNDS AND ACCOUNTS

- a) Bank account shall be opened only in the name of the Association in a scheduled or nationalized bank and the same shall be operated by President or Secretary.
- b) The nature of the funds of the Association may be Permanent and Current.
- c) The Permanent Funds shall consist of:
- Life membership fees from members.
 - Donations contributed specifically to Permanent fund.
- d) The Current Fund shall consist of:
- Interest derived from Permanent Funds.
 - Amount set apart from Permanent Funds with the approval of the General Body.

h) General Body may appoint an honorary Chief Alumni Advisor to assist coordination of Alumni activities if necessary.

The following business shall be transacted at these General Body meetings:

- i. To adopt and approve the annual report and the audited statement of accounts.
- ii. To consider and approve the budget for the following year.
- iii. Election of members to the Executive Committee for the ensuing period
- iv. To appoint an auditor
- v. To consider any modifications to the Rules and Regulations
- vi. To transact any other business relating to the Association

IV. MANAGEMENT

The association shall be managed by an Executive Committee selected by the General Body at the Annual General Body Meeting of the Association as provided below:

- i. President, Vice President, One Secretary, One Treasurer and eight selected members by General Body as regional convenors.
- ii. The regional convenors are the permanent invitees to the Executive Committee meetings.
- iii. Faculty Alumnus to function as the secretary.
- iv. Trust Directors, Institute Director, the Principal, and the Placement officer/ Alumni Coordinator shall be the ex-officio members.

a) The Association shall be managed by an Executive Committee elected by the General Body.

b) The term of the Executive Committee shall be for two years. However, the same committee may continue for the succeeding years with the consent of the General Body.

c) The Executive Committee shall meet as often as is necessary but not less than twice a year.

d) All Executive Committee Meetings shall be presided over by the President or in his absence one member assigned by the President.

d) The membership shall cease:

- i. On the submission of resignation by a member
- ii. On the untimely death of a member

e) Student membership holders can participate in the deliberations of the meetings and have the voting rights to elect the office bearers or to contest for the post of office bearers.

f) If for any reason, the membership of any person has been terminated; such person shall have no claim to demand repayment of any subscription or donation that has been paid to the association.

III. GENERAL BODY

a) The General Body shall comprise of all the registered members who have acquired membership through clause (b) and (c) of membership. However, the honorary members shall have no voting rights.

b) General Body shall meet at least once a year which shall be held at such as the Executive Committee may decide with the concurrence of the Institute Director.

c) A special General Body meeting may be convened if 50 registered members or 50 percent of registered members request the Secretary in writing. On receiving such a request, the Secretary shall convene a Special General Body Meeting in consultation with the Institute Director.

d) The notice for the General Body meeting shall be given at least 21 days before the meeting.

e) The quorum for the General Body Meeting shall be 15 or 1/5 of the number of members registered.

f) The President, Institute Director & Placement officer/Alumni Coordinator together shall decide the conduct of General Body meetings.

All General Body Meetings shall be presided over by the President or in his absence by one member assigned by the President.


